Methodology Statement

Latino Decisions interviewed 1,200 Latino registered voters between June 24th to July 8, 2015. California and Florida were oversampled, with 300 interviews completed in each of those states. The sample interviewed is a blend of landlines, mobile numbers, and on-line, weighted to match known population characteristics from the Bureau of the Census. Interviews were conducted in English or Spanish, according to the respondent's preference. The overall nominal margin of error is +/- 2.8 percentage points. The state samples carry a nominal margin of error of +/-5.7 percentage points.
