METHODOLOGY

On behalf of NCLR, Latino Decisions interviewed a total of 700 Latino registered voters currently in the workforce. The study was conducted between May 12-25, 2017. Interviews were conducted in English or Spanish, according to the respondent's choice. Surveys were completed using a blended sample that included live telephone interviews on landlines and cell phones, and online surveys. The overall survey carries a margin of error of +/- 3.7 percentage points.
